MAGIC SPRAY & SHINE FURNITURE POLISH

HOW TO USE

- Use directly from the bottle as a ready to go solution and requires no dilution with water.
- For the best results do not over use. Shake the bottle before use and spray a thin coating from a distance of approximately 30cm evenly over the surface. With a soft cloth remove any soiling then using a duster polish and buff the surface to leave a rich gloss finish.
- Although housekeepers traditionally like the smell of furniture polishes, in many cases this type of product is not required especially when using on non-absorbent laminates or veneer surfaces.

- A furniture polish works best on porous surfaces; this means a surface that absorbs the product. A furniture polish works by penetrating the surface and depositing waxes that make the wood surface shine due to conditioning.
- When cleaning laminates/veneers use a multi-purpose cleaner only. Do not use in conjunction with a multi-purpose cleaner as chemical residues can build up and leave tacky surfaces.

SAFETY ADVICE

Wear protective gloves. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical attention.
