##### INSTRUCTIONS FOR USE:

##### Two stage cleaning for hard surface (best practice):

Stage 1 Clean: Remove any loose/visible soiling from surface. Apply directly to surface or with a damp cloth/sponge and wipe away all visible dirt and limescale from surface.

Stage 2 Sanitise: Re-apply to surface and allow recommended contact time (30 seconds for protocol EN 1276). Rinse cloth in fresh warm water, wring out and wipe surface clean. Buff with a clean cloth/paper towel for extra shine or allow to air dry.
