

Non-Biological Washing Powder

Cleanline® Non-Biological Washing Powder is a premium detergent suitable for sensitive skin and high-quality formula that helps remove the most stubborn stains.

The prescribed dosage will depend on soiling level, size of machine and water hardness.

Soft	60ml / 40g	75ml / 50g	100ml / 68g
Medium	75ml / 50g	100ml / 68g	115ml / 78g
Hard Water	100ml / 68g	115ml / 78g	140ml / 95g

Washing machine >5kg add an additional 30ml / 20g of powder to the recommended wash.

Handwash: Dissolve 50ml of powder per 10l of water

INSTRUCTIONS FOR USE:

Pour the recommended amount of powder either directly into the dispenser drawer or into a dosing device. If using a dosing device, place it in an upright position on top of the laundry in the machine. Do not pre-wash when using a dosing device or put a dosing device into tumble cycles of washer driers.

Manual Washing: Use 1/2 cup / 50ml in a 10 litre bucket of warm water. Ensure powder is fully dissolved before putting articles into water. Allow items to soak. Remove and rinse thoroughly.

DO NOT USE AN ENAMEL BATH FOR SOAKING. NEVER SOAK SILK, WOOL, LEATHER OR GARMENTS WITH METAL FASTENINGS OR FLAME RESISTANT FINISHES.

ALWAYS TEST COLOURED ARTICLES FOR COLOUR FASTNESS IN A SMALL, INCONSPICUOUS PLACE BEFORE USE. IF NOT COLOUR FAST WASH SEPARATELY.

AVOID CONTACT WITH SKIN AND EYES. WEAR PROTECTIVE CLOTHING. WASH HANDS AND ANY OTHER CONTAMINATED AREAS OF THE BODY WITH SOAP AND WATER AFTER USE. DO NOT EAT, DRINK OR SMOKE WHEN USING THIS PRODUCT.
